Description :

1. File encoding: UTF-8 without BOM.
2. Each column should be separated by “|”. (Each record has 112 columns and 111 “|”.)
3. Each record should be separated by End-Of-Line (CR+LF (0D0A in hex)).
4. Numeric column (attribute S9 or 9): “Zero” should be padded to the left sides of the vacant digits.
5. Column content shouldn't have End-Of-Line.
6. Please remove the extra blanks before and after each column.
