Description:

1. I intend to install green energy facilities on the rooftops for

2. Enclosed are three copies of facility drawings (illustrating the proposed construction items, locations, roof area usage, height, and a brief schematic diagram).

Affidavit:

1. Upon approval from the agricultural competent authority to install green energy facilities as attachments to agricultural facilities' roofs, I hereby undertake to carry out and utilize them strictly in accordance with the approved specifications and to observe relevant soil and water conservation measures.
2. If there is a need to change the approved usage for other purposes after the application, I agree to seek consent from the leasing authority beforehand. In case of unauthorized changes for alternative purposes, I consent unconditionally to the leasing authority terminating the lease agreement.
3. If the lease contract is terminated or revoked, the leasing authority is not obliged to provide any compensation. Within the specified period set by the leasing authority, I agree to remove any non-state-owned structures or buried waste from the land and return it. If I fail to restore the land to its original condition within the specified period, the leasing authority may remove it at my expense, and I have no objection to this.
4. I am willing to apply for permission to use from the agricultural competent authority within one year after obtaining the land consent certificate issued by

the leasing authority. Upon completion of the agricultural competent authority's review, I will notify the leasing authority of the approval results. After obtaining approval from the agricultural competent authority, along with the approved specifications (including drawings) and completion photos, a copy of the building permit (if exempted according to relevant building regulations, provide a letter of exemption from the regulatory building authority for reference), and a copy of the approval from the energy authority, I will submit these documents to the leasing authority for their records. If one year passes without applying for permission to use from the agricultural competent authority after obtaining the land consent certificate, or if permission is denied by the agricultural competent authority, or if the construction is not carried out in accordance with the approved specifications or not used according to the approved content, resulting in the cancellation of the permit by the agricultural competent authority, I agree to restore the agricultural facilities to their original state. Otherwise, the leasing authority may terminate the lease agreement and vacate the state-owned land at my expense, and I have no objection to this.

5. After obtaining the land consent certificate from the leasing authority, I hereby undertake that the installation of green energy facilities on the roofs of agricultural facilities will not interfere with the agricultural facilities' purpose and will be integrated with agricultural operations.
