Consent Letter for the Use Right on the Leased National Land**

shown in the attached diagram), the total roof area for installation is _____ square meters. With the approval of this branch, this certificate is hereby issued for permission to use from the competent authority of the local municipality or county (city), or the appointed or entrusted township (town, city, district) under their jurisdiction (hereinafter referred to as the agricultural competent authority). The lessee shall comply with relevant regulations on building management. The green energy facilities to be installed as attachments should apply for a building permit according to relevant building regulations. An additional copy of this certificate will be issued for the lessee to apply to the regulatory building authority after obtaining permission for use. For those exempt from applying for miscellaneous permits according to the law, the lessee should follow the standard regulations for setting up renewable energy facilities to exempt the application for miscellaneous permits. This certificate is valid for one year, and it will be void if not applied within the specified period.

Note:

1. This certificate approves the installation of green energy facilities as attachments to agricultural facility roofs, in accordance with the Regulations for Examining the Application of Structuring Farming Facilities on Agricultural Land formulated by the Council of Agriculture, Executive Yuan. It is only for

the lessee to apply for permission to use from the agricultural competent authority, and does not exempt the lessee from the obligation to apply for relevant permits from various regulatory authorities as required by law.

2. Upon completion of the agricultural competent authority's review of the application for permission to use, the lessee should notify the leasing authority of the approval results. For cases approved by the agricultural competent authority, the lessee should submit, after the completion of the construction of green energy facilities attached to the roofs of agricultural facilities, along with the approved specifications (including drawings) and completion photos from the agricultural competent authority, a copy of the building permit (if exempted according to relevant building regulations, provide a letter of exemption from the competent building authority for reference), and a copy of the approval from the energy authority to the leasing authority for their records.
3. If the lessee fails to apply for permission to use from the agricultural competent authority within the specified period, or if permission is denied by the agricultural competent authority, or if the construction does not conform to the approved specifications, or the usage does not comply with the permitted content resulting in the revocation of the permit by the agricultural competent authority, and the lessee fails to restore the agricultural facilities to their original state within the specified period after being requested by the leasing authority to do so, the leasing authority may terminate the lease agreement and vacate the state-owned land. The cost of clearing shall be borne by the lessee.
4. The green energy facilities installed as attachments to the roofs of agricultural facilities shall not interfere with the agricultural facilities' purpose and should be integrated with agricultural operations.
