### Affidavit:

- I hereby commit that upon approval for the construction of the relevant facilities by the agricultural competent authority, I will diligently adhere to the approved specifications and utilize the facilities accordingly. Additionally, I will ensure compliance with relevant soil and water conservation measures.
- In the event of any intended change in the approved usage to other agreed-upon purposes after the application, I shall first obtain consent from the leasing authority. If there is any unauthorized change in usage for other purposes, I willingly agree to unconditionally terminate the lease agreement at the discretion of the leasing authority.
- In the event of termination, expiration, or revocation of the lease agreement, the leasing authority is not obligated to provide any compensation. Furthermore, I agree to dismantle and vacate any non-national structures or bury any waste materials within the stipulated period set by the leasing authority, and return the land. Should I fail to restore the land to its original condition within the specified timeframe, the leasing authority reserves the

right to vacate the national land at my expense, and I have no objections to this arrangement.

4. I undertake to apply for permission to use the land from the agricultural competent authority within one year of receiving the land consent certificate issued by the leasing authority. Subsequently, upon the completion of the agricultural competent authority's review, I will promptly notify the leasing authority of the approval status. Following approval from the agricultural competent authority, I will provide the leasing authority with the necessary documentation, including the approved content (including facility plan) from the agricultural competent authority, completion photos, and a copy of the building permit (lessees exempt from building permit application in accordance with construction related laws and regulations are excused from submitting a copy of building permit), for their records. Failure to comply with the aforementioned conditions, such as not applying for permission within the stipulated period, refusal of permission by the agricultural competent authority, or failure to adhere to the approved construction and usage conditions, will result in the land reverting to its original designated use. In such cases, the leasing authority reserves the right to terminate the lease agreement and vacate the state-owned land at my expense, and I hereby agree to this without objection.
5. Upon receiving the land consent certificate from the leasing authority, if there arises a need to apply for the transfer of leasing rights involving subdivision, I agree to dismantle any facilities on the individual subdivided leased land that do not comply with the provisions outlined in Article 6 of the Directions for Inspecting Facilities Permitted in Agriculture Land of the Leasing National Non-public Use Land without any conditions prior to subdivision.
