- 6. The import and export merchandises released by Customs are recorded in the trade statistics in the month which the corresponding declarations have undergone review, which ends on the 2nd day of the following calendar month
- 7. Goods are classified according to Customs Import Tariff and Import and Export Commodity Classification of the Republic of China except for the following:
- (1) An exclusive commodity classification code "9899.00.00.00-6" is used for a shipment with C.I.F./F.O.B. value under NT\$50,000, the miscellaneous and other specific goods.
- (2) Tariff quota goods will be included in trade statistics in accordance with their respective commodity classification code instead of those in Chapter 98 specializing for tariff quota in Customs Import Tariff and Import and Export Commodity Classification of the Republic of China. Any addition or deletion to the code of commodity classification except for 9899.00.00.00-6 will be effective on announcement by the Bureau of Foreign Trade, Ministry of Economic Affairs.
- 8. The value of trade statistics is recorded according to the following:
- (1) The value of import statistics is recorded on the basis of C.I.F., while the value of export statistics on the basis of F.O.B.
- (2) The value of merchandise is displayed in NT or US thousand, million, or hundred million dollars and rounded to the nearest whole number.
- (3) The same currency exchange rate from NT dollar to US dollar is applied to either imports or exports, which is the average of selling and buying rates announced by Customs Administration, Ministry of Finance every 10 days in a month for filing customs declaration purpose.
- 9. The units of measurement are shown by their abbreviations on the list of "Units of Measurement" of Customs Import Tariff and Import and Export Commodity Classification of the Republic of China; and the quantity of weight stands for net weight.
- 10. The country (area) in trade statistics is compiled based on the following:
- (1) The country (area) of imports (including re-imports) refers to country (area) of origin.
- (2) The country (area) of exports (including re-exports) refers to country (area) of last known destination.
- 11. Statistics Office of Customs Administration may derive statistical information from customs declarations and validate.
- 12. Statistics Office of Customs Administration may request regional Customs to review the items of declarations after data validation.
- 13. Statistics Office of Customs Administration develops an advance release calendar pursuant to Statistical Data Dissemination Directions of Government Agencies and releases trade statistics periodically.
- 14. Trade statistics are released on a monthly basis.
- The preliminary monthly data is issued at the beginning of next month. Revisions to the preliminary monthly data are made 2 months later. Adjustment applied to the prior monthly data shall be issued in the yearly figures in February of the next year; revisions to the annual data shall be issued in September of the next year.
- 15. The aggregate trade statistics data without disclosure of the name of the duty-payer or exporter of goods is disseminated and provided in the following ways:
- (1) Data can be accessed for free on the official website of Customs Administration, Ministry of Finance.
- (2) Monthly (annual) statistics of imports/exports published in electronic formats are available.
- (3) Trade statistics data on CD-ROMs can be purchased.
- (4) Data can be provided freely to the government agencies to cater to their operation needs.
- The provision of trade statistics data which may disclose the name of the duty-payer or exporter of goods shall be governed by Paragraph 1 of Article 12 of the Customs Act.
- 16. Customs statistical personnel, in accordance with Paragraph 1 of Article 12 of the Customs Act, shall keep declaration information received in the statistical process confidential.
