(3) Facilities shall be established in accordance with Subparagraph 6, Paragraph 1, Article 8 of the Act where the overall investment (excluding cost of land) amounts to more than NT\$1 billion. III. Agricultural facilities established pursuant to Subparagraphs 1 and 2, Paragraph 6, Article 21 of these Enforcement Rules of Act for Promotion of Private Participation in Infrastructure Projects and any of the following requirements: (1) Facilities for value-added activities of fishing where the overall investment (excluding cost of land) amounts to more than NT\$200 million. (2) Facilities for accommodation, food and beverage, exhibition and ocean-related recreation and education where the overall investment (excluding cost of land) amounts to more than NT\$200 million.
Article 22	Government office buildings where the overall investment (excluding cost of land) amounts to more than NT\$1 billion.
